On successful completion of the Part I Registration after generation of unique Registration Number, the payment gateway can be accessed by clicking on the link **"Click here to make payment"** under **Post Apply tab**

### **Step I**

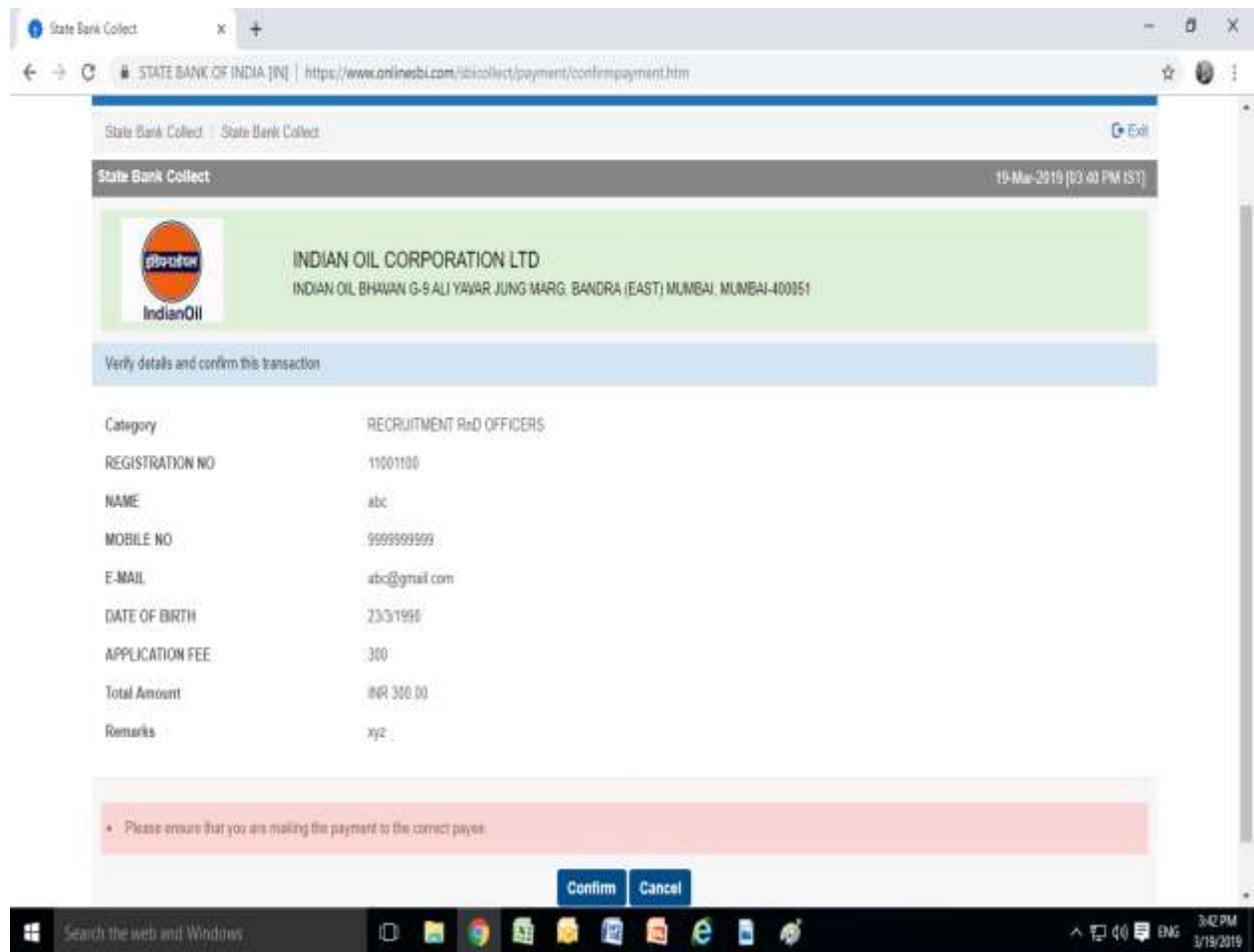

## Step VII

The fee is to be submitted on-line through SBI E-Collect using either SBI Debit Card or through Net-Banking or by selecting "Pay at Branch option". Candidates opting for "Pay at Branch option" can download the challan and submit the application fee at the branch.

**Note:** Applicants who are unable to "Pay at Branch" by Cash on the closing date i.e. during banking hours at SBI branch, for reasons whatsoever, even if holding valid Pay In Slip will have no other offline option but to make the payment online through either SBI Debit Card or through Net-Banking payment mode on closing/ last date.
