- Date of activation of the Online Application for the post will be notified shortly. Candidates are advised to be in constant touch with the above website to apply for the post.
- Candidates are required to apply through Online mode only after publication of the detailed advertisement in the website.
- Before applying for the post the candidate must go through the Detail Advertisement and ensure their eligibility for the post.
- On the basis of information given in the Online Application Form candidates will be allowed to appear different stages of examination and if at any stage it is found that he/she has furnished false or incorrect information his/her candidature will be rejected forthwith.
- No Physical copy of application required to be sent to this Commission. Candidates are required to upload relevant valid documents/certificates, visible scanned photograph and scanned signature. They have to produce original at the time of document verification and viva-voce - cum-psychological test.
- Candidates have to download admission letter from the above website for appearing the examination at different Stages of recruitment. No Admission letter will be sent by post..
- In-service contractual candidates claiming benefits will also have to follow the advisory notice published vide No.3658/ dtd.01.11.2019 available in the Commission's website.

- Note: 1. Women candidates are not eligible to apply for the post of station officer (Fire Service).
2. PWD candidates are not eligible to apply for the above posts.

ELIGIBILITY:-

- Age- Must not be below 21 years and above 25 years of age as on 01.01.2019.
- The upper age limit:- 5 years in case of ST,SC,SEBC & Women candidates and period of service rendered in Armed Forces in case of Ex- Servicemen. In-service contractual Employees who have rendered at least one year of continuous service prior to commencement of the Odisha Group- B posts (Contractual Appointment) Rules, 2013 and are below 45 years of age are eligible
- Minimum Educational Qualification- Must have passed a graduate degree in any discipline from a recognised university. The candidates applying for the post of Station Officer (Fire Service) must be a Science or Engineering Graduate.
- The candidates who have not taken Odia as a subject in HSC standard must possess requisite certificate of passing ME standard in Odia as a Language subject.

OPTION:- The candidates as per their eligibility for the post may exercise their option for different posts in order of preference.

CONDITIONS OF SERVICE: Conditions of Service for the post shall be guided by Odisha Group-B posts (Contractual Appointment) Rules, 2013 and amended up to date.2. Combined Competitive Recruitment Examination for Group-B Posts of Orissa Police Service, Orissa Fire Service Orders, 2008.

REMUNERATION:- The appointment will be initially on contractual basis carrying a monthly remuneration of Rs. 16,880/- (for 1st year) as per Odisha Group-B posts (Contractual Appointment) Rules, 2013 and subsequent amendments.

PLAN OF EXAMINATION:

The recruitment process consists of 1. Preliminary Examination 2. Physical Measurement & Physical Test 3. Main written Examination 4. Assessment of weightage mark for NCC Certificate, winning medal in National /International sports events as per the uploaded documents at the time of applying for the post 5. Viva voce – cum- Psychological Test.

EXAMINATION FEES- The candidates other than SC & ST category shall have to pay examination fee of Rs. 200/- through online mode as per details to be published in the detailed advertisement.
