Applications from desirous candidates on the prescribed Form are invited for filling up 239 posts of Animal Husbandry Attendant ( Peon and one post of Chowkidar in the Directorate) to be filled up against vacant posts available as well as newly opened Dispensaries and upgraded Hospitals in Department on daily wages basis. **The application should reach in the office of Deputy Director(Animal Health/Breeding) of concerned District , on or before 30<sup>th</sup> March, 2020 at 4:00 PM positively, and the candidate of Tribal Areas of Himachal Pradesh Shall be given an additional time of 15 days i.e 16<sup>th</sup> April upto 4 PM) to submit their applications in the office of the concerned Deputy Directors.** The applications received after due date or found incomplete will be rejected straightway without assigning any reason. The department will not be responsible for delay in receipt of applications due to any reasons whatsoever.

Essential Qualification	Should be Matric pass or its equivalent from recognized Board of School Education/Institution.
Desirable Qualification	Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.
Age	The applicant should be between 18 to 45 years as on 01-01-2020. The upper age limit is relax-able by 05 years for candidates belonging to SC/ST/OBC.
Place of Posting	Concerned District in Himachal Pradesh .

**Mode of Selection:-** Selection will be done strictly on the basis of parameters fixed by the Govt. vide Notification No. Per(AP.B)B(15)5/2014 dated 17<sup>th</sup> April 2017, as under:-

Vi BPL family having annual income (from all sources) below Rs. 40,000/- or as prescribed by the Govt. from time to time.

=2.5 marks

Vii Widow/divorced/destitute/single woman

= 1.5 marks

Viii Single daughter/orphan

=01 marks

Ix Experience up to a maximum of 5 years in Govt. /Semi-Govt. organization relating to the post for (0.5 marks only for each completed year)

- 3 The candidate must fulfill all the required essential educational and other qualifications on the last date fixed for the submission/receipt of application forms
- 4 Incomplete application forms e.g. declaration not signed, without photo and enclosures not attached and columns not filled in or applications received after due date shall be rejected summarily without assigning any reason.
