STENOGRAPHER, GRADE-II (POST CODE 09/19)
IN DELHI POLLUTION CONTROL COMMITTEE**

1. The DSSSB vide its Advertisement No. 02/2019 with closing dated 05.03.2019 had advertised 06 vacancies (UR-05, OBC-01) for the post of Stenographer, Grade-II in Delhi Pollution Control Committee (DPCC) under Post Code 09/19. Board Conducted Tier-I written examination for recruitment in respect of this post on 27.08.2019.
2. On qualifying Written Examination, vide Notice No. 861 dated 18/12/2019, the DSSSB has shortlisted 62 candidates for appearing in Skill Test/Shorthand/Typing Test for the post of Stenographer, Grade-II under post code 09/19. The Skill Test/Shorthand/Typing Test was conducted on 24/12/2019 wherein out of 62 candidates, 28 candidates appeared for the test. In the Skill Test/Shorthand/Typing Test conducted, out of 28 candidates only 07 candidates could qualify.
3. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered up to 7% mistakes in Shorthand skill test for UR category and up to 10% mistakes in Shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RRs for the Post the candidate was to Qualify the 40 w.p.m. in Typewriting in English or 35 w.p.m. in Typewriting in Hindi, as well.
4. The roll nos. of 07 candidates who have qualified the skill test/ Shorthand/Typing Test are as under:-

5. Based on the performance in the written examination and being qualified in Skill Test/Shorthand/Typing Test, 07 candidates (UR-05, OBC-02) as per details given below are being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

6. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Shortlisting is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.
7. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
8. All the candidates who have been shortlisted for falling in consideration zone of selection **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
9. The e-dossier link shall be active from 12/10/2020 to 26/10/2020. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 05/03/2019.
10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
11. All the candidates who have shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time i.e. 12/10/2020 to 26/10/2020.
12. **Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.**
13. The above shortlisting of candidates for calling of e-dossier for the post code -09/19 will be subject to outcome of pending court cases, if any.
14. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
