AIR FORCE COMMON ADMISSION TEST (AFCAT) - 2021/22 NCC SPECIAL ENTRY FOR COURSES COMMENCING IN JANUARY 2022

1. Online applications are invited for the courses commencing in January 2022 for grant of Short Service Commission (SSC) in Flying Branch and Permanent Commission (PC) and Short Service Commission (SSC) in Ground Duty (Technical and Non-Technical) Branches. Online applications are also invited for grant of PC/SSC for NCC Special Entry Scheme (For flying branches).

3. Type of Commission

- PC for Men:** Candidates joining as PC officers would continue to serve till age of superannuation as per their branch and rank.
- SSC for Men & Women:**
 - The engagement period for Flying Branch SSC officers is fourteen years from the date of Commissioning (Non-renewable).
 - The initial tenure for SSC officers in Ground Duty (Tech and Non-Tech) branches would be for a period of ten years. An extension of four years may be granted subject to service requirements, availability of vacancies, willingness, suitability and merit.
 - Grant of Permanent Commission (PC) to SSCs would be considered in the extended tenure of service only as per prevailing policies on the subject at the time and subject to service requirements, availability of vacancies, willingness, suitability and merit.

4. Age

- Flying Branch:** 20 to 28 years as on 01 January 2022 i.e. born between 02 January 1993 to 01 January 2002 (both dates inclusive). Upper age limit for candidates holding valid and current Commercial Pilot License issued by DGCA (India) is reduced upto 30 year i.e. born between 02 January 1967 to 01 January 2002 (both dates inclusive).
- Ground Duty (Technical/Non-Technical) Branches:** 20 to 28 years as on 01 January 2022 i.e. born between 02 January 1967 to 01 January 2002 (both dates inclusive).

5. **Notification:** Detailed notification is available on website <https://careerindianairforce.cdac.in> or <https://afcat.cdac.in>. Candidates are to ensure that they have read and understood the details available in the notification before registering.

6. **Physical/Medical Standards, Educational Qualifications and Selection Procedure:** Details on physical/medical standards, educational qualifications and selection procedure are available in detailed notification on the website.

7. **Training:** Training will commence in the first week of January 2022 for all courses at Air Force Academy Dundigal (Hyderabad). The duration of training for Flying and Ground Duty (Technical) Branches is 14 weeks and that of Ground Duty (Non-Technical) Branches is 52 weeks at Air Force Training Establishments. Pass Card and account in SBBI Nationalised Bank is mandatory at the time of joining Air Force Academy. Aadhaar Card is mandatory for registration.

Note: Flying Cadets shall receive a fixed stipend of Rs. 50,100/- per month during one year of training.

8. **Allowances:** In addition to pay, allowances are applicable based on the nature of duty place of posting and it includes Flying, Technical, Field Area, Special Compensatory (240 area), Special Perms, Schemes, Special Ground Duty, Test Pilot & Flight Test Engineer, Area and Remote Locality Allowance.

9. **Quarters:** Air Force Officers are entitled to furnished accommodation, comprehensive medical cover for self and dependents, Caravan, Officers Mess,

bars at subsidised rates, LTC etc. Leave (90 days annual) subject to service exigencies.

10. **Insurance:** Rs. 1 crore Insurance Cover can cover serving officers. An additional cover of Rs. 12 Lakh (per year) Flying Branch Officers.

11. **Sports and Recreation:** Indian Air Force provides to play various sports and adventure activities (sky diving, mountaineering, water rafting etc.).

IMPORTANT INSTRUCTIONS

12. Eligible candidates are to register online through afcat.cdac.in only. NCC Special Entry/Allowance only, premium entries are to register separately in each entry.

13. **Photos:** The policy on permanent body tattoos is as follows: Permanent body tattoos are not permitted on any visible or non-visible part, except on the lower leg inside of the shins in the case of both the hands or on the back (small) side of both hands for which a tattoo sign a Self-declaration Certificate. Small tattoos (provided in good order and military discipline) are permitted on hands of men and feet of men.

14. **Visas:** Visas with letter marks on the face of both sides and features will be permitted on a case to case basis.

15. **Records:** User possession of records is being tested for presence of drugs in the body during tests during training service courses as an officer. If candidate is possession of records during any time of training service it be obtained from joining the Indian Air Force or be removed prior.

16. **Conduct of Online Testing for AFCAT Examinable:** Online testing will be conducted for AFCAT entry at various registering for AFCAT entry will have to pay an amount of Rs. 1 as examination fee. However, candidates registering for NCC required to pay details of conduct of exam, examination payment are available in the notification.

17. **Marital Status:** Candidates below 25 years of age as time of commencement of the course, Widows/Widowers and unmarried/never married below 25 years of age are also not eligible.

18. **Candidates are required to maintain their unique reg mobile phone number active throughout the selection process.**

19. **Please note that information filled up by the candidate in the application form will be considered final and no change allowed subsequently. Candidates should monitor due date of tests.**

20. **Travel Allowance (TA):** To avail the traveling fare by AC/1st Tier AC Chair Car or equivalent class fare will candidates appearing in Air Force Selection Board for the 1 modes of travel. TA will be admissible as per the Government TA is admissible, if you have already appeared for the seat of the Selection Board.

21. **Physical Conditioning:** You are advised to be fit report for SSC in order to be able to undergo the tests at AF. achieve an ability to run 27 mile (43 km) in 10 minutes, do 10 ups. Prospective candidates are also advised to keep themselves in shape to adapt to physical training at IFA which a swimming, rope climbing and other forms of physical training they would undergo mandatory tests during training.
