**Note-** Every candidate is strictly advised to adhere to the COVID guidelines as notified by the Government from time to time while attending the document verification process.

- i) The candidates are required to submit their Hard copy of online application form **mentioning Roll No. at the top right corner** and **one passport size photograph pasted** on it and **02 additional passport size photographs tagged** to the application form, along with **01 passport size photograph pasted on the Attestation form**.
- ii) The candidates are required to mention **“Submitted by me” on each Xerox copy** of documents and put their **full signature and date** on the same.

**The candidates are required to submit the following original certificates/ photo copy of documents at the time of verification:-**

1. **H.S.C. or Equivalent Certificate and mark sheet** in support of declaration of age issued by the concerned Board.
2. **Intermediate/ +2 Examination Certificate and mark sheet** issued by the concerned Board/ Council.

3. **B.H.M.S. Degree Certificate and mark sheet passed including fail marks**, if any, issued by the concerned University.
4. **Conversion Certificates/ Conversion Formula** wherever applicable.
5. **Medical Registration Certificate under the Odisha State Board of Homoeopathic Medicines. (Issued within last date of submission of online application form i.e., 25.06.2021).**
6. **Caste Certificate by birth** in Support of claim as SCs/ STs (Please see and refer Note- 2 of the Advertisement).
7. **SEBC Certificate by Birth (issued within 3 years by the closing date for submission of online application form i.e. 25.06.2021)**, wherever applicable.
8. **Required Odia Test Pass Certificate** from the Competent Authority, wherever applicable.
9. **Permanent Disability Certificate (Indicating % of benchmark Disability)** issued by the concerned Medical Board, wherever applicable.
10. **Discharge Certificate** issued by the Commanding Officer of the Unit last served in respect of Ex-Servicemen candidates, wherever applicable. **Ex-Servicemen** must submit an **affidavit undertaking that he has not been appointed against any civil post after retirement from military service**, wherever applicable.
11. **Sports Certificate** issued by the Director of Sports Odisha, wherever applicable. If a candidate claims to possess qualification, equivalent to the prescribed qualification, the rule/authority (with number and date) under which it is so treated, must be furnished with the application form.
12. **Attestation Form duly filled-in, signed and attested** by a Gazetted Officer **(to be downloaded from the website of the Commission).**
13. **No Objection Certificate** from the Head of Office in respect of Government Servants/ In-service Homoeopathic doctors.
14. **Aadhar Card** as a proof of Identity.
