1. Fee and submission of Application:

The fee prescribed for applying to the post of Medical Officer (Ayurveda/Homoeo/Unani/Naturopathy) on contract basis is **Rs.600/- (Rupees six hundred Only)** towards Demand Draft infavour of Accounts Officer, Department of AYUSH, T.S., Secunderabad between 25/5/2022 to 31/5/2022 till 5:00PM and submit the application at O/o. the Commissioner, Department of AYUSH, Secunderabad, Telangana State

NOTE ON IMPORTANT LEGAL PROVISIONS:

(a) **Vacancies:** The recruitment will be made to the vacancies notified only. There shall be no waiting list as per the G.O.Ms.No.81, General Administration (Ser.A) Department, Dated 22-2-1997. In any case, no cognizance will be taken by Department of any vacancies arising or reported after the completion of the selection and recruitment process or the last date as decided by the Department as far as this Notification is concerned, and these will be further dealt with as per above G.O.

(b) The Rule of Reservation is applicable.

2. EDUCATIONAL QUALIFICATIONS:

Medical Officer: (Ayurveda) (Homoeopathy) (Unani)

- i "Must possess a Graduate Degree in Ayurveda/ Homoeo/ Unani, awarded by any University in India established or incorporated by or under Central Act or an Institution recognized by the University Grants Commission or any Statutory Board of State Government" in the concerned specialty /Allied as per the existing National Commission for Indian System of Medicine Norms.
- ii. Preference will be given to PG degree in the concerned system

- iii Must be a permanent Registered Medical Practitioner within the meaning of law for the time being in force in Telangana

Medical Officer: Naturopathy

- i. Must have passed intermediate or its equivalent examination.
- ii. "Must passed a Degree/ Diploma in Naturopathy or Yoga from a recognized institution/ statutory board/ University/ Institution aided by Central or State Government.
- iii Must be a permanent Registered Medical Practitioner within the meaning of law for the time being in force in Telangana

3. CASTE & COMMUNITY:

Community Certificate issued by the Competent Authority (obtained from Government of Telangana State) in terms of G.O.Ms No. 58, SW (J) Department., dated: 12-05-1997 read with G.O. Ms. No. 5, Scheduled Castes Development (POA.A2) Department, dated 08-08-2014, G.O. Ms. No. 11, Scheduled Castes Development (POA.A2) Department, dated 17-09-2014 and G.O. Ms. No. 2, Scheduled Castes Development (POA.A2) Department, dated. 22-01-2015 should be submitted at appropriate time in respect of SC Candidates.

In respect of candidates belonging to Backward Classes are required to produce Community Certificate (Socially & Economically BC -A, BC-B, BC-C, BC-D & BC-E) from Competent Authority i.e., from Tahsildars in the State of Telangana not below the rank of Deputy Tahsildar through E-seva/Mee-seva (G.O. Ms. No. 16 BCW(OP) Department, dated 11-03-2015) and orders and instructions issued by the Government from time to time and as per the General Rules for State and Subordinate Service Rules, 1996 issued by the Government of Telangana through G.O.Ms.No.196, General Administration (Services-D) Department, dated 8-05-2016. Rule - 2(28) Explanation: No person who possess a religion different from Hinduism, the Sikh or buddhist shall be deemed to be a member of a Schedule Caste as per the explanation under Sub-rule 29 of Rule 2 of the Telangana State and Subordinate service Rules, 1996 issued through G.O.Ms.No.196, General Administration (Services-d) Department, dated 28-05-2016.

4. RESERVATION:

Where there is only a single solitary post borne on the class, or category of a service, the rule of special representation shall not apply for appointment to such post, not with standing anything contained in the foregoing sub-rules:

Provided that the rule of special representation shall be applicable for appointment if the number of posts borne on the cadre, category of grade is more than one, even though selection is to be made against only one vacancy at any recruitment other than limited recruitment as per Rule 22 (j) of the Telangana State and Subordinate Service Rules, 1996 issued through G.O.Ms.No.196, General Administration (Services-D) Department, dated. 28-05-2016.

5. AGE:

OCs -Not above - 44 Years as on 1st /July/2022.
SC/ST/BCs - Not above - 49 Years as on 1st /July/2022.

Not exceeding (44) years as on 1st July 2022 for OCs and for SC/ ST/BCs - (49) as per the provisions contained in the Telangana Ayurvedic Medical Service Rules issued in G.O. Ms.No. 69, HM&FW (I2) Deptt; dt. 14.3.2005 adapted vide G.O. Ms.No. 39, HM&FW (E.1) Deptt; dt. 30.5.2016 and Telangana State and Subordinate Service Rules,

1996 issued through G.O.Ms.No.196, General Administration (Services-D) Department, dated. 28-05-2016.

6. GENERAL PROVISIONS:

1. Applicant must compulsorily fill-up all relevant columns of the application and submit application at O/o. the Commissioner, Department of AYUSH, Secunderabad. The particulars made available in the application shall be processed and the eligibility decided in terms of the notification.
2. The applications received in the prescribed proforma within the time shall only be considered and the Department will not be held responsible for any kind of discrepancy.
3. Applicants must attach his/her own recent passport size photo and signature across it.
4. The applicants should not furnish any particulars that are false, tampered, fabricated or suppress any material information while making an application.
5. All the original essential certificates issued by the competent authorities of the Telangana State shall compulsorily be kept with the applicants to produce as and when required to do so. Failure to produce the required certificates on the day of verification will lead to disqualification.
6. The persons already in Government Service / Autonomous bodies/ Government aided institutions etc., whether in permanent or temporary capacity or as work charged employees are however required to inform in writing to their Head of Office / Department that they have applied for this recruitment.
7. Important – The claim of the candidates with regard to the date of birth, educational / technical qualifications, experience and community are accepted only provisionally on the information furnished by them in their application form and is subject to verification and satisfaction of the Departmental selection committee. Mere inclusion of the name of a candidate in the Merit List will not confer on the candidate any right for appointment. The candidature is therefore, provisional at all stages and the Departmental selection committee reserves the right to reject candidature at any stage of the selection even after the advice has been made.

7. DOCUMENTS REQUIRED (SELF ATTESTED):

The candidates should attach the self-attested copies of the following document along with the Original Application:

- 1) SSC/SSLC Class Certificate (for proof in support of Date of Birth)
- 2) a) BAMS/BUMS/BHMS/BNYS Degree Certificate, PG degree certificate (in the concerned subject.)
(b) Degree in Ayurveda/ Homoeo /Naturopathy/ Unani awarded by a University in India established or incorporated by or under Central Act or State Act or Provincial Act or an Institution recognized by the UGC or any statutory board of the State Government after having undergone regular course of Institutional study in the Ayurveda both in theory and Practical for a period not less than (4½) years duration in a Teaching Institution recognized by the University or state Government with one year compulsory Internship.
- c) Marks Statements of all the years/ Semesters of Professional Degree issued by the University Concerned.
- d) Copies of the marks memo if issued by the university in MD Degree
- 3) Certificate of completion of internship.
- 4) Certificate as Registered Medical Practitioner from the Telangana State Board of Indian Medicine (upto date /Renewed)

- 5) Study Certificate from Class I to VII-issued by the School/Institution, which is recognized by the Govt.
- 6) Social Status Certificate for SC/ST/BC issued by the Telangana State.
- 7) Residential /Nativity certificate issued by Concerned MRO is to be considered only in respect of candidates who have not studied a regular schooling from I to VII (i.e, Open school / Private study).
- 8) Demand Draft (DD) for an Rs.600/- in the favour of Accounts Officer, Department of AYUSH, T.S., Secunderabad
- 9) PG degree Certificate

The following Certificates should be obtained from Govt. of Telangana State in the prescribed proforma to be furnished at the time of verification of certificates:

- i. Community Certificate.
- ii. Non-Creamy Layer Certificate as per Form- VIIB / Creamy Layer Certificate as per Form-VII C.
- iii. Certificate of Residence / Nativity (where the Candidates not studied in School/ Private Study)

8. RULE OF RESERVATION IS APPLICABLE TO LOCAL CANDIDATES:

- A. Local Candidature is applicable as per the Go.Ms.No.124 GA (SPF-MC) Dept., Dated.30-08-2018 and the Government instructions in force.

B. NOTE:

Residence Certificate will not be accepted, if a candidate has studied in any educational institution up to S.S.C. or equivalent examination, such candidates have to produced study certificates invariably. The candidates, who acquired Degree from Open Universities without studying SSC/Matriculation or equivalent in Educational Institutions, have to submit Residence Certificate only. Educational institutions means a recognized institution by the Government / University / Competent Authority. The Open school students must invariably enter the residence particulars in the Application form

9. METHOD OF SELECTION:

- (i) Aggregate of marks obtained in all the UG Degree exam (BAMS/BUMS/BHMS/BNYS).
- (ii) Preference will be given to the candidates having MD in concerned system.
- (iii) There will be no interview.
- (iv) Candidates selected and appointed will be governed by the rules of Government regarding service conditions, emoluments, eligibility criteria and all other matters connected with service.

All the appointments will be done as per the provisions of Presidential Order and as per the Rule of Reservation.

10. INSTRUCTIONS TO CANDIDATES:

- 1) The candidate must note that his/her selection for counselling is strictly provisional. The mere fact that calling for counselling does not imply that his/her candidature has been finally cleared by the department or that the entries made by the candidate in his/her application have been accepted by the department as true and correct
- 2) The above appointments are purely temporary on contract basis.
- 3) They should stay at the Headquarters as per posting compulsorily.
- 4) Selected candidates shall be liable to serve to the state of Telangana. If selected he/she should join in the place where he/she is posted within the stipulated time, failing which the selection of such candidates stands cancelled.

11. DEBARMENT:

- 1) Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- 2) The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Department will be sufficient cause for rendering such questionable means ground for debarment.


13. DISTRICT SELECTION COMMITTEE DECISION IS FINAL:

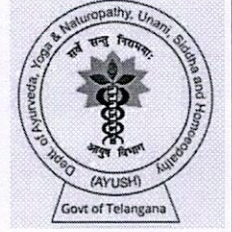

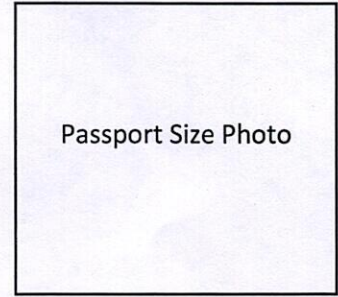
