### **NOTICE FOR RECRUITMENT OF JUNIOR RESIDENT ON REGULAR BASIS**

Online applications are invited from Indian Nationals for the post of Junior Resident (MBBS) under Residency Scheme in this hospital on Regular Basis for a period of six months extendable upto one year only, subject to the satisfactory work & conduct report from HOD/In-charge concerned, after completion of initial term of engagement of six months-

#### **1. VACANT POST OF JUNIOR RESIDENT**

#### **2. MODE OF SELECTION /SELECTION CRITERIA**

- Eligibility criteria for Screening will be decided on the basis of number of applications received.
- The selection will be made on the basis of Screening Test/Interview subject to the number of applications received.

#### **3. ELIGIBILITY FOR THE POST OF JUNIOR RESIDENT**

##### **1. EDUCATIONAL QUALIFICATION :-**

MBBS Degree from a NMC recognized University/ Institute. Foreign Graduates must have cleared FMG Examination.

##### **2. AGE LIMIT :-**

Cut-Off date as on date of interview is as follows-

- 30 years for UR Category Candidates
- Relaxable by 05 years for **ST** Category.
- Relaxable by 03 years for **OBC** Category (OBC Certificate issued by Revenue Deptt., GNCTD shall only be considered).
- Relaxable for **Pwd** candidates is as per extant rules.

##### **3. INTERNSHIP :-**

Must have completed one year rotatory internship after completion of MBBS. **Internship should not have been completed on or before 30-09-2020.**

##### **4. REGISTRATION :-**

Must have valid DMC Registration, **candidates having Acknowledgment Slip need not apply.**

##### **5. PAY SCALE :-**

Pay in the Pay Matrix of Level - 10 (Rs. 56100-177500), plus other usual allowance as admissible under the residency rules.

## 6. TENURE :-

The tenure of Junior Resident on regular basis is for a period of one year including any service rendered as Junior Residency earlier on adhoc/regular basis in any recognized government institution. The appointment will be initially for a period of six months that can be extended further for a period of six months subject to satisfactory performance work and conduct report from concerned HODs.

## GENERAL TERMS AND CONDITIONS

1. Selection/Appointment is purely on provisional basis, subject to Verification of Educational Certificates & Other related Certificates/antecedents and the candidate being found Medically Fit.
2. Candidates currently working on adhoc basis in Indira Gandhi Hospital are also eligible to appear.
3. The candidate must not have done Junior Residency of ONE year from any recognized institute.
4. Number of the vacancies is provisional and subject to change without any notice.
5. Candidates who wish to be considered against reserved vacancies or wish to seek relaxation(s), must be in possession of relevant certificates (SC/ ST/ EWS/ OBC/ Non-creamy Layer/ PwD etc.) issued by the Competent/ Notified Authority (in prescribed format) on or before the date of interview otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies.
6. Candidates notified as OBC, by Govt. of NCT of Delhi shall only be accorded benefit of reservation/ age relaxation under OBC category. **Such OBC candidates must also be in possession of Non Creamy Layer Certificate for the current financial year, alongwith OBC Certificate.**
7. In case any of the candidate is not found to be belonging to SC/ ST/ OBC/ EWS Category and information/ Certificate furnished in this regard is found fake/false, services of such candidates shall be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false information/ fake certificate
8. The service condition will be regulated in terms of Residency Scheme, 1983 issued by MoHFW, GoI, or any other extant Rule(s)/ Office Memorandums issued by Deptt. of H&FW, GNCTD in this regard.
9. Any candidate, if working on regular basis must produce NOC from present employer.
10. **No TA/DA is admissible to appear in Screening Test/interview.**
11. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
12. Residence proof: Voter ID Card/Passport/Driving License/Aadhaar Card etc.
13. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
14. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any stage.
15. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
