- 4. Norms for appearing the Walk-in-interview:
 - A. Interested candidates are requested to appear before the Interview Board along with his/her Biodata as per the prescribed format (Format Enclosed) and all original documents with two copies of recent Passport Size Colour Photograph.

B. Self-attested photocopy of the following documents needs to be submitted: (a) Copies of qualification (Mark Sheet & Pass certificate) from Madhyamik onwards, (b) Permanent Registration Certificate from Medical Council of India/ State Medical Council,(c) Caste Certificate (for reserved categories), (d) Permanent Resident Certificate of Tripura (PRTC), (e) Age Proof (Madhyamik Admit Card)/ 10th Standard Board Admit Card), (f) Photo ID with address (Aadhar card/ Driving license/ Voter ID).

5. Age relaxation limit:

- **A.** 42 years for UR candidates & 47 years for SC/ST candidates for all categories of post for MBBS Doctors.
- **B.** For Specialist Doctors the upper age limit is 62 years, for all categories of candidates.

7. <u>Candidates' selection criteria:</u>

The candidates will be selected based on their merit on the basis of total marks obtained by the candidate. Total maximum score is 100 marks. Out of 100 marks, 75 marks is for academic performance from their 1st Professional MBBS is & viva-voce/ performance of the Interview Board is 25 marks for both MBBS & Specialist cadre.

8. Instructions:

- 1. Vacancies shall be subject to the State Reservation Policy of Tripura. Horizontal reservation for women in the posts shall be applicable as per the policy notified by the State Government. Only those candidates having the Permanent Resident Certificate of Tripura (PRTC), issued by the Govt. of Tripura shall be eligible.
- 2. In the case of CGPA/ GPA, applicants shall provide marks details in percentage at the time of filling the online form and documentary proof for the basis of calculation of percentage shall be produced whenever it is required. If the applicant fails to present the above, supporting documents s/he shall be liable for the disqualification/ cancellation of her/ his candidature.
- 3. T.A. & D.A. will not be admissible for appearing the recruitment procedure.
- 4. The selected candidate will have to perform their duties for a minimum of 06 to 08 hours in a day.

- 6. The in-service Candidates (State Govt. or Society) are not allowed for the said post.

If at any stage of recruitment, it is found that the candidate does not fulfil the eligibility criteria and/or that she/ he has furnished incorrect/ false information/ certificate/ documents or has suppressed any material fact(s), his/her candidature shall stand cancelled, apart from taking actions as per legal provisions.
