### AGE CRITERIA:

- Minimum 18 years and maximum 25 years as on 08.02.2023. That is, the Date of Birth of the Candidate/Applicant should be between 09.02.1998 and 09.02.2005.
- **Concession & Relaxation:** (Upper age is relaxed by 5 years for SC/ST candidates and 3 years for OBC candidates for the trades reserved for them).

**STIPEND:** ₹9,000/- p.m. for ITI Holders and ₹10,000/- p.m. for Diploma Technicians.

**PERIOD OF APPRENTICESHIP TRAINING:** The duration of Apprenticeship training will be for a period of one year as per Apprentices Act, 1961, as amended from time to time.

### SELECTION METHODOLOGY:

- I. Selection of the apprentices will be through written test/Computer based test and/or personal interview, which will be communicated to applicants through their registered email ID. Final selection will be done based on merit and reservation rules.
- II. The candidature of the applicant would be provisional and subject to subsequent verification of certificates. In case it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement, his/her engagement is liable to be terminated.

- IV. On successful completion of document verification and the execution of Apprenticeship contract agreement, letter of engagement shall be issued to the candidates.

## **GENERAL CONDITIONS:**

- VI. The above posts is purely temporary as indicated against respective trades.
- VII. Please note on completion of period of apprenticeship training in GMRC the apprentice shall have no rights to claim any employment from GMRC on the basis of this apprenticeship at any point of time.
- VIII. All provisions and guidelines with respect to Reservation for SC/ST OBC will be followed – as per Apprentices Act. Candidates from SC/ST/OBC categories are to submit original caste certificate as per Government's standard format. Candidates from OBC category should bring OBC certificate as per the Govt. prescribed format from the certificate issuing authority.
- IX. The decision of Management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, higher qualification etc. No correspondence will be entertained in this regard.
