

The TNPSC Civil Judge Preliminary Examination for 2023 will be conducted online in an objective format. It is a graduate-level exam consisting of 100 multiple-choice questions. The exam will be conducted in both Hindi and English, except for language subjects. The total marks for the exam are 100, and candidates will have 180 minutes to complete it. Each correct answer will be awarded 1 mark, while 0.25 marks will be deducted for each incorrect answer due to a negative marking. The subjects covered in the preliminary exam will be specified by the TNPSC.
