TATA STEEL MILLENNIUM SCHOLARSHIPS 2023-2024

NOTICE

Applications are invited from sons/daughters/spouse of Workers, Supervisors and Officers of the Company for the Tata Steel Millennium Scholarships subject to their being eligible as indicated below: -

- a) Sons/Daughters/Spouse of all existing Workers, Supervisors and Officers of the Company.
- Sons/Daughters/Spouse of superannuated Workers, Supervisors and Officers of the Company including those separated under ESS/SBKY/Job for Job/MSS/EFBS/FBS/FSS/ FPS/Second Inning.
- Sons/Daughters/Spouse of Workers, Supervisors and Officers of Tata Steel who were transferred on the rolls of JUSCO.
- d) Aforementioned candidates who have secured admission in the full time and regular courses as detailed below in the academic year 2023-2024 are eligible to apply. Postal/Correspondence courses will not be considered.
- e) 10% seats are reserved for SC/ST students in each category of the Scholarship Scheme.
- f) 60 seats are reserved for wards where employee has availed current Sunhere Bhavishya Ki Yojana (SBKY -2.0/3.0) (20 seats in Category-A & 40 seats in Category-B).
- g) Preference will be given to the physically challenged wards of employees.
- h) Last date for submitting applications complete in all respect form for each category is 29th February 2024.

TYPES OF SCHOLARSHIPS:

CATEGORY- A:

Scholarships under this category are awarded to candidates who have secured admission in the institutions as specified in Annexure-I, will be entitled for a scholarship of Rs. 75,000/- (Rupees Seventy-five Thousand only) per annum. This will include students studying in MBBS (4.5 years) in all State, Private & Central Government Medical Colleges admission through NEET. No Internship payment will be given to candidates studying MBBS.

The number of scholarship under Category-A is limited to a maximum of 120 (80 seats for wards of Workers and Supervisors general candidates, 20 seats for Wards of Officers general candidates and 20 seats for wards where employee has availed Sunhere Bhavishya Ki Yojana [SBKY] – 2.0).

CATEGORY-B:

No postal course will be considered for scholarship.

Scholarships under this category are awarded to candidates who have secured admission in any of the professional courses in Institutions mentioned below:

Total Number of Scholarship = 240 (130 for Boys & Girls, 30 for Girls only, 40 for wards of officers and 40 seats for wards where employee has availed Sunhere Bhavishya Ki Yojana [SBKY – 2.0]) under Category-B.

Scholarship amount Rs.36, 000/- (Rupees Thirty six Thousand) per annum.

1) Discipline

- Integrated degree courses in Medicine or Engineering (any branch), including extension centers of BITS Pilani, VIT-Vellore and BIT-Mesra.
- b) Post graduate studies in Engineering, Medicine, Computer Sciences, Business Management, Personnel Management, Agriculture Science, Bio-Technology, Bio- Chemistry, Information Technology and B.Sc. Hospitality & Hotel Management.
- c) Diploma course in any branch of Engineering.
- d) Degree or Full Time Diploma courses in Hotel Management & Catering and Fashion Technology.
- e) Five years degree Course in Law, Five years integrated course in Law.
- f) Degree course in Journalism / Mass Communication.
- g) Sports Management.
- h) Film Fine and Arts.
- i) Courses and Institutes as per Annexure-2.

Scholarship under the Category A & B as mentioned above are also awarded to Candidates perusing fulltime Graduation / Post Graduation degree courses from a recognized University / Institute outside India.

The Millennium Scholarship Committee will decide on the eligibility of the University/ Institute outside India and the Category (A or B) for awarding Millennium Scholarship.

2) Institutions

Admission for the above disciplines should be secured at only those Colleges / Institutions that meet the following criteria:

- a) Are affiliated to a recognized University.
- b) Are autonomous Institutions or deemed Universities with official recognition from bodies such as AICTE and which have an all-India competitive selection procedure.
- c) For studies in Hotel Management & Catering and Fashion Technology, campus of National College of Hotel Management and Catering Technology (NCHM & CT) or institutions of Catering Management set up by the Taj Group, the Oberoi Group, ITC Welcome Group and ITDC Group of Hotels would be considered.
- Full time Graduation/Post Graduation degree courses from a recognized University/ Institute outside India.

AWARD FOR STUDENTS OF R D TATA TECHNICAL INSTITUTE:

Five top overall rank holders of RD Tata Technical Institute, from each of the four discipline will be awarded Rs.10,000/- (Rupees Ten Thousand only) on a one time basis payment as per their Final year annual examination result. List of such meritorious students will be procured from the Institute directly.

No application from individual is required under this category.

GENERAL CONDITIONS FOR SCHOLARSHIP:

- All applications will be placed before the Committee and the decision of the Committee will be final and binding on the applicants and employees / ex-employees.
- A minimum 60% mark is required under General Category and 50% marks for SC/ST students in their last qualifying examination for being eligible to be considered for the Scholarship.

iii) In case, there are more than 120 applications in Category – A. First 120 applications based on marks will be awarded scholarship in Category – A. Rest all applications of category – A will be moved for consideration in category – B.

All applications of Category – B including those moved from Category – A to Category B will be ranked as per marks and the first 240 applications as per the marks will be awarded scholarship in Category – B.

As per the above process, applications of Category A, if awarded scholarship in Category B, will get the amount of Category B as scholarship amount.

- iv) Candidates getting aid/scholarship from any other college/institution will not be considered for Millennium Scholarship. In case the candidate starts getting any aid/scholarship from any college/institution after getting the Millennium Scholarship, then he/she would have to forgo either the Millennium Scholarship or the other aid/scholarship. The candidate will have to inform the Committee and he cannot get simultaneously another aid/scholarship in addition to Millennium Scholarship.
- v) Those getting admission to specified colleges/Institutions on the basis of an All India competitive selection procedure only will be eligible. A self-attested photocopy of Admit Card is to be attached along with the application form for verification of appearing in the all India competitive selection process.
- vi) Scholarship will be discontinued in case of unsatisfactory performance by the candidate or if there is any unsatisfactory report from the Head of the Institution about the progress and conduct of the candidates. Minimum 50% marks or equivalent must be secured for awarding scholarship for the next installment in all the courses of studies by the student.
- vii) A maximum of 2 (two) scholarships will be awarded to the wards of the employee / ex-employee under this scholarship. Any false/wrong declaration in this regard by an employee will lead to appropriate disciplinary action.
- viii) Annual payments of the scholarship amounts to the concerned students in the subsequent years will only be made when he/she submits an attested photocopy of passed mark sheet from the Registrar/Principal/Dean of the College, Self-attested confirming the successful completion by the student of the preceding year of the academic course along with renewal form duly certified every time by the Departmental Head/BU HRM Executive of the department confirming the current status of the employee in the company.

The scholarship will be remitted to the student by Cheque or Bank Draft only, to the address specified in the application form. Selected candidates would be advised to open a bank account for a swift transfer of scholarship amount, if selected.

ix) Candidates of employees who were dismissed /discharged from the services for misconduct or resigned from the services of the Company are not eligible for the scholarship. If the employee is, separated from the Company for these reasons after the commencement of the scholarship to the candidate, the payment of further installments of the scholarship would be discontinued forthwith.
