Notification inviting applications from meritorious Sportspersons in the disciplines listed in **Annexure-I** for appointment as Postal Assistant/Sorting Assistant, Postal Assistant (CO/RO), Postman and Multi Tasking Staff are called for, under sports quota against the vacancies as furnished below.

2. Meritorious Sports Candidates will be selected for appointment based on the instructions contained in the Department of Personnel & Training OM No.14034/01/2013-Estt.(D) dated 03.10.2013 communicated vide Directorate letters No.14-01/2013-PAP dated 14.10.2013 & No.17-18/2016-SPB-I dated 16.11.2017 as amended from time to time. Extracts of which are reproduced below.

3. Order of Preference:

- a) First preference to those candidates who have represented the country in an international Competition with the clearance of the Department of Youth Affairs and Sports.
- b) Next Preference will be given to those who have represented a State/U.T in the Senior or junior level national Championships organized by the national Sports Federations recognized by department of Youth Affairs & Sports or national Games organized by Indian Olympics Association and have won medals or Positions up to 3rd place. Between the candidates participating in Senior and junior National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference.
- c) Next preference will be given to those, who have represented a University in an Interuniversity competition conducted by Association of Indian Universities/ Inter University Sports Board and have won Medals or positions upto 3rd place in finals.
- d) Next preference will be given to those who have represented the State Schools in the National sports/games for Schools conducted by the All-India School Games Federation and have won medals or positions upto 3rd place.
- e) Next preference will be given to those, who have been awarded National Award in Physical efficiency under national Physical Efficiency drive.
- f) Next Preference will be given to those who represented a State/ Union Territory/ university/ State Schools Teams at the level mentioned in Categories (b) to (d) but could not win a medal or Position, in the same order of preference.



NOTE 1: In the event of tie, those who have secured a higher position or won more than one medal will be given the preference.

NOTE 2: Participation in individual and team event / item may be given the same preference.

NOTE 3: No preference will be given for winning more than one medal/ position.

- NOTE 4: In case of any doubt about the status of tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports and Youth Affairs.
- NOTE 5: Decision of the competent authority i.,e Chief Postmaster General, Andhra Pradesh Circle, Vijayawada-13 will be binding on all.
 - **4.** The last date for receipt of applications is fixed as <u>30.01.2018</u>. The applications received after <u>30.01.2018</u> will not be considered.

5. Eligibility:

(a) Age for the vacancies of PA/SA/PA(CO/RO)/Postman:
18 to 27 years as on 30.01.2018 (Last date of receipt of Applications).

Upper age limit is relaxable as follows: For General - upto 5 years For OBC- upto 8 years For SC/ST - upto 10 years

(b) Age for the vacancies of Multi Tasking Staff:

18 to 25 years as on 30.01.2018 (Last date of receipt of Applications).

Upper age limit is relaxable as follows: For General - upto 5 years For OBC- upto 8 years For SC/ST - upto 10 years

This concession will be available only to those sports persons who satisfy all other eligibility conditions relating to educational qualifications etc. and furnish a certificate from the appropriate competent authority as per the specimen copy enclosed.

6. Educational qualifications:

- (a) Postal Assistant/Sorting Assistant/Postal Assistant (CO/RO):
 - (i) A pass in 10+2 Standard or 12th class from Recognized University/Board of School Education Board of Secondary Education/National Institute of Open Schooling (NIOS) /Open universities recognized and affiliated to NIOS with English as a compulsory subject.
 - (ii) Candidates with higher qualification are also considered but they have to fulfill the requirements mentioned in sub para (i) above. There are no bonus marks for higher education.
 - (iii) Candidates who have passed 12th standard/10+2 in vocational courses or Job oriented course are not eligible.
 - (iv) Having Typing knowledge and computer knowledge upto the required standard is desirable.
 - (v) Sports qualification as mentioned at Para 8 below.



(b) Postman:

- (i) A Pass in Matriculation from a recognized Board/University.
- (ii) Candidates with higher qualification are also considered but they have to fulfill the requirements mentioned in sub para (i) above. There are no bonus marks for higher education.
- (iii) Sports qualification as mentioned at Para 8 below.

(c) Multi Tasking Staff:

- (i) A Pass in Matriculation/ITI from a recognized Board/ University.
- (ii) Candidates with higher qualification are also considered but they have to fulfill the requirements mentioned in sub para (i) above. There are no bonus marks for higher education.
- (iii) Sports qualification as mentioned at Para 8 below.

9. Submission of Applications:

- (a) The Notification can be downloaded from Andhra Pradesh Postal Circle web site www.appost.in and www.indiapost.gov.in.
- (b) The applications as indicated in Annexure-II can be downloaded from Andhra Pradesh Postal Circle Website www.appost.in and www.indiapost.gov.in.
- (c) Applications purchased from outside vendors will not be accepted.
- (d) If a candidate desires to apply for more than one post (PA/SA, PA(CO/RO), Postman & MTS) / discipline (Sports event) he has to submit separate applications for each

post (PA/SA, PA(CO/RO), Postman & MTS)/discipline (Sports event) application fee separately for each application. If the candidate applies for more than one post/ discipline through one application, the same will not be considered for any post/ discipline and will be summarily rejected. Post/discipline for which applied should be specifically mentioned.

10. Application Fee:

All the Applicants have to pay an application fee of Rs100/- (Rupees One Hundred only) in the form of Indian Postal Order. Applicants have to enclose an Indian Postal Order of value of Rs 100/- (Rupees One hundred only) drawn in favour of Chief Postmaster General, Andhra Pradesh Circle, Vijayawada-520013. The application fee in any other means i.e, Cheque/ Demand Draft /UCR will not be accepted and all such applications will be rejected.

Note: Fee once paid shall not be refunded under any circumstances.

11. Method of Selection:

- Selection of candidates will be made on the educational and sports qualification and subject to fulfillment of other prescribed conditions.

The most suitable and fit candidates will be considered. Selected candidates have to compulsory participated in the circle team during All India Postal Tournaments for specified years by the department.

12. Disqualification:

- (a) No person who has entered into or contracted a marriage with a person having spouse living; or
- (b) No person who has a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to service. Provided that Central government may, if satisfied that such marriage is permissible under the personnel law applicable to such person and to the other to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

13. SPECIAL INSTRUCTIONS TO THE APPLICANTS:

- (a) Original certificates should not be submitted. Self attested Photo copies should be sent. Certificates without attestation will be rejected.
- (b) Attested copies of all the required documents and certificates should be sent along with the application. The documents/marks lists/certificates submitted at a later date will not be entertained.
- (c) If the prescribed / required documents are not submitted along with the application, application received after due date will be rejected and no request for revival will be considered.
- (d) Incomplete or unsigned applications or applications without photographs or applications received after due date will be rejected.
- (e) Before submitting the application, the candidate must carefully read the eligibility conditions and satisfy himself that he fulfills all the eligibility conditions for the post which he has applied.
- (f) Community certificate for SC/ST & OBC in the prescribed form from the competent authorities, as in Appendix II and III respectively are to be submitted. <u>Certificates submitted in any other form or from authorities not competent to issue the same will be ignored.</u>

(g) The applications should be sent through Speed/Regd Post only. Those sent arrogard any other means, Private couriers/Un-regd. post and given by hand shall not be accepted.

- (h) One envelope should contain application of one candidate for one event only.
- (i) Applications wrongly addressed or received after due date are liable to be rejected, whatever may be the reason for delay. Applications without required certificates and incomplete applications are liable to be rejected. No intimation will be sent in this regard.
- (j) The selected candidates shall be posted anywhere in Andhra Pradesh Postal Circle.
- (k) The selected candidates of all posts are liable to serve anywhere in the Circle and as and when required at the sole discretion of the appointing authority.
- (l) Once appointed, request for transfer will not be entertained for 5 years.
- (m) Selection of candidates will be in accordance with the relevant recruitment rules and administrative instructions issued by the Department of Posts from time to time.
- (n) The candidate should give an undertaking that he will serve the Department for a minimum period of three years, if selected in the proforma given. The services of Candidates who will leave the job within three years will be terminated under Rule-5 of CCS (Temporary service) Rules, 1965.
- (o) The Department reserves the right either to revise the number of vacancies or to cancel the recruitment, if so warranted and the Department will not be liable to return the fee or pay any compensation on the applicant's application.

- (a) All marks lists of Education qualifications.
- (b) Proof in respect of Sports qualification/achievements.
- (c) Proof for Date of birth.

- (e) Two latest identical Pass Port Size Photographs (one to be pasted on the application and the other sent loose with name and address written on the reverse).
- (f) Duly filled in Application Form itself with signed under taking form.

Note:

- (i) Candidates to submit paper clippings if any published in the news paper on winning of awards/prizes in support of the certificate.
- (ii) Copies of photos taken while receiving the awards in support of the certificate.
- (iii) Certificate signed by the Secretary of the concerned Sports Board only will be accepted. Certificates issued by President/ others of the Sports Board will not be entertained.
- (iv) If already employed, details of the organization. If the candidate presently practicing in the relevant sports and if so date from which practicing and the name of Institution where practicing etc.
- (v) Write up in brief on what he/she will do in the Department in the relevant Sports/Event if she/he is selected in 15 lines.
- 15. The application in the form attached to this prospectus (Annexure II) completed in all respects may be sent to "The Chief Postmaster General (Recruitment Section), Andhra Pradesh Circle, Krishnalanka, Vijayawada-520013." The application along with attested copies of requisite certificates should reach on or before the date mentioned in the notification at para 4. Applications received after due date are liable to be rejected.

The applications should be sent through Speed Post/Registered Post only. Those sent through any other means, private couriers, by Unregistered post and given by hand shall not be accepted.



16. INSTRUCTIONS RELATING TO SUBMISSION OF APPLICATION:

- (a) Write the required information In English.
- (b) One envelope should contain application of one candidate for one post/ discipline only.
- (c) The envelope containing the application must be super-scribed in bold letters as "APPLICATION FOR THE POST OF POSTAL/SORTING ASSISTANT/ POSTAL ASSISTANT(CO/RO)/POSTMAN/ MTS IN ANDHRA PRADESH POSTAL CIRCLE UNDER SPORTS QUOTA". The name of the post and discipline for which applied should be clearly mentioned on the envelope. (Format of addressing envelope is mentioned in Annexure-III).
- (d) An application will be rejected at any stage of recruitment process for not having been submitted in the official format/having incomplete information / wrong information / misrepresentation of facts / unsigned / without photographs / not accompanied by attested copies of required certificates.
- (e) If a candidate has changed his name or dropped / added part of his name after Matriculation/SSLC/Hr. Secondary, proof for the change of name such as Affidavit, Gazette Notification, etc., should be enclosed.

NOTE: Only certificates issued by the competent authorities, for example, the Universities/concerned Boards would be accepted as proof for having possessed the minimum educational qualifications or date of birth. Only those certificates issued by the competent authorities and in the prescribed form would be considered.

 - (e) Check whether you have mention the details of fee paid and enclosed Indian Postal Order (IPO).
 - (f) Check whether application form has been signed in full by you.

(g) Check whether you have enclosed the signed undertaking form.




